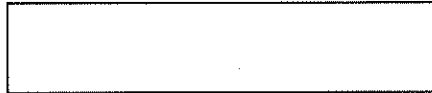

Statement of Fact

The Office of the Attorney General requests authority to establish one limited-period Assistant Attorney General position. The position will be assigned to the Litigation Division. Funding for this position is from the Department of Corrections. The position will be effective on March 1, 2021 and will end on June 30, 2021. In fiscal year 2021-22, another financial order will be submitted to continue the position.

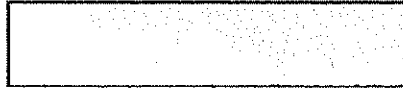
